NOTIFICATION

No.10/60/2010-4BE/240.-In compliance with the directions of Hon'ble Punjab and Haryana High Court order dated 22.11.2013 and 18.12.2013 in Civil Writ Petition No. 6902, 6671, 9631, 9709, 15449 of 2010, 2941 of 2011 and 5153 of 2012-K.P.S. Gill Versus Punjab Public Service Commission and others, the Governor of Punjab is pleased to constitute a Special Investigating Team (SIT) comprising of the following :-

2	Sh. Suresh Arora, IPS , DGP-cum- Chief Director , Vigilance Bureau, Punjab, Chandigarh	Member

2. The Special Investigation Team (SIT) is empowered to enquire /investigate into the matter within a period of four months.

3. All departments are required to render assistance to the SIT to complete the task expeditiously.

4. The Special Investigation Team (SIT) shall furnish the report/s to the Hon'ble High Court from time to time and after the completion of the preliminary enquiry.

5. To facilitate the completion of preliminary inquiry in a time bound manner, the following operational team as required by SIT shall be made available as follows:-

a) An operational team of one Inspector General of Police, four SPs, three DSPs, five Inspectors, Four Sub Inspectors, Five Assistant Sub Inspectors, Five Head Constables and 20 Constables may be required to assist the SIT along with other infrastructure and logistics support including vehicles with drivers, Ministerial Staff, office equipment and residential accommodation. The said operational team would consist of serving/retired, officers/ranks from the CBI, Chandigarh Police, the Central Police Organizations and the Punjab Vigilance Bureau.

b) The Special Investigation Team (SIT) shall be free to work out the modalities and the norms required to be followed for the purpose of preliminary enquiry.

c) The fee of the Chairperson SIT Sh. M.S. Bali for the task would be Rs. 1.75 Lac per month plus

travel facility to be provided or entitlement as per the position/status last held. However, the emoluments of other retired officers may be fixed at a monthly consolidated amount of Rs. 1,00,000/- for the SPs, Rs. 75,000/- for the DSPs, and Rs 60,000/- for the Inspectors. For the serving officers / ranks taken on deputation, the usual govt. rules for fixation of pay shall apply.

d) The head quarter of the Special Investigation Team (SIT) will be at Patiala .

e) A corpus fund of Rs. 10.00 Lacs is being provided to the Punjab Vigilance Bureau for this purpose with the concurrence of Finance Department Separately.

6. In order to ensure the speedy completion of preliminary enquiry as directed by the Hon'ble High Court, Sh. Suresh Arora, IPS, DGP Vigilance Bureau, member SIT is authorized to issue necessary orders regarding empanelment/cooption/attachment/Deputation of officers and vehicles to the SIT.
