Applications received from candidates for engagement as **ADDITIONAL ADVOCATE GENERAL** for the State of Punjab were scrutinized by the Scrutiny Committee constituted under Section 6(1) of the Punjab Law Officers (Engagement) Act, 2017. The Committee has scrutinized such applications as regards registration certificate with Bar Council of India, for the minimum experience prescribed for the each category and remarked against each applicant either 'Experience criteria met with' or 'Experience criteria not met with'. The Committee has also examined applications in terms of the minimum gross annual income from profession and categorized the applications in 04 (four) categories as mentioned below:-

Sr. No.	Category	Details
1	Minimum Professional Income is certified by C.A.	The applicants have submitted the C.A. Certificate as prescribed in the advertisement dated 6.01.2018.
2	Minimum Professional Income is verified.	The applicants whose income meets the criteria as per the financial documents submitted other than the C.A. Certificate.
3	Income Proof not submitted.	The applicants neither submitted C.A. Certificate nor ITR form and computation sheet.
4	Income Criteria not met with.	The applicants whose income is shown less in C.A. Certificate than the minimum professional income prescribed and ITRs and computation sheets are also shown less income than the minimum professional income prescribed.

In the interest of the justice and fair opportunity and to ensure that inadvertently any eligible candidate is not erroneously eliminated at the stage of scrutiny by this Committee, all the applications are being forwarded to the Selection Committee with remarks in terms of experience and minimum gross annual income from profession in the last three years.
