Applications received from candidates for engagement as ADDITIONAL ADVOCATE GENERAL for the State of Punjab were scrutinized by the Scrutiny Committee constituted under Section 6(1) of the Punjab Law Officers (Engagement) Act, 2017. The Committee has scrutinized such applications as regards registration certificate with Bar Council of India, for the minimum experience prescribed for the each category and remarked against each applicant either 'Experience criteria met with' or 'Experience criteria not met with'. The Committee has also examined applications in terms of the minimum gross annual income from profession and categorized the applications in 03 (three) categories as mentioned below:-

Sr. No.	Category	Details
1	Minimum Professional Income certified by C.A.	The applicants have submitted the C.A. Certificate as prescribed in the advertisement.
2	Minimum Professional Income not certified by CA.	The applicants have not submitted the C.A. Certificate as prescribed in the advertisement .
3	Minimum Professional income certified by CA but less for one/two/all three years.	The applicants have submitted the C.A. Certificate but the income certified by CA is less for One year or two years or all three years, as the case may be.

In the interest of the justice and fair opportunity and to ensure that inadvertently any eligible candidate is not erroneously eliminated at the stage of scrutiny by this Committee, all the applications received in time as per advertisement and in prescribed format are being forwarded to the Selection Committee with remarks in terms of experience and minimum gross annual income from profession in the last three years.
