No. 12/7/2020-4HG1/ 1227 Whereas it appears to the Governor of Punjab that to meet the challenge of rapid growth of Bhikhiwind town of district Tarn Taran and to provide for a workable framework for its comprehensive planned and regulated development, the preparation of statutory master plan of Bhikhiwind town is very essential. Hence in order to develop Bhikhiwind town and its surroundings in an orderly manner and to prepare its master plan under "The Punjab Regional and Town Planning and Development Act, 1995," the Governor of Punjab is pleased to declare the Local Planning Area of Bhikhiwind town within the meaning of sub section (1) of section 56 of "The Punjab Regional and Town Planning and Development Act, 1995". The total area proposed for Local Planning Area Bhikhiwind is 75,447 hectares (1,86,433.6 acres) including Bhikhiwind town and 147 adjoining villages. The schedule of boundary of Local Planning Area is given below:-

SCHEDULE OF BOUNDARY

NORTH: Starting from point 'A' which is the intersection point of village Naushera (HB No. 177), Indo-Pak International boundary and village Bharobhal of district Amritsar (HB No. 427), moving towards north along the western revenue boundaries of village Naushehra (HB No. 177), village Burj (HB No. 169), crossing Attari-Tarn Taran road and again moving along the western revenue boundary of village Burj (HB. No. 169), then moving towards east along northern revenue boundary of village Jathaul (HB No. 422) of district Amritsar, then continue moving towards east along northern revenue boundary of village Bhusse (HB No. 171), village Kasel (HB No. 29), village Dhand (HB No. 34), village Jagatpura (HB No. 33), village Thathgarh (HB No. 32), village Khair Dinke (HB No. 41), crossing UBDC along the eastern revenue boundary of village Khair Dinke (HB No. 41) and crossing Khemkaran-Amritsar road, again moving along eastern revenue boundary of village Khair Dinke (HB No. 41), northern revenue boundary of village Rakh Bhohru (HB No. 42) upto point 'B' which is the intersection point of revenue boundaries of village Rakh Bhohru (HB No. 42), village Mandiala (HB No. 268) of Local Planning Area, Amritsar and village Pandori Ran Singh (HB No. 51) of Local Planning Area, Tarn Taran.

EAST:- Thence from point 'B' moving towards south along the eastern revenue boundaries of village Rakh Bhohru (HB No. 42), village Pandori Sidhwan (HB No. 47), northern revenue boundary of village Pandori Rahman (HB No. 48), then moving towards north along western revenue boundary of village Pandori Takhat Mall (HB No. 49), then moving towards south along eastern revenue boundary of village Pandori Takhat Mall (HB No. 49), village Johal Raju Singh (HB No. 59) and northern revenue boundary of village Tharu (HB No. 60), crossing Amritsar-Bathinda road (NH-54), then moving towards south along eastern and southern revenue boundary of village Tharu (HB No.

60), again crossing Amritsar-Bathinda road (NH-54) and continue moving along the southern revenue boundary of village Tharu (HB No. 60), eastern revenue boundary of village Kila Kavi Santokh Singh (HB No. 61) crossing Attari-Tarn Taran road, then again moving along the eastern revenue boundaries of village Kila Kavi Santokh Singh (HB No. 61), village Jarmastpur (HB No. 218), village Bakipur (HB No. 219), then moving towards east along northern revenue boundary of village Kot Jaspat (HB No. 220), village Daleke (HB No. 221), village Gorkha (HB No. 244), village Walipur (HB No. 245), then moving towards south along eastern revenue boundary of village Rure Asal (HB No. 246), crossing Patti-Amritsar railway line and again moving along the eastern revenue boundary of village Rure Asal (HB No. 246), village Mughal Chak (HB No. 251), then moving towards east along northern revenue boundary of village Dyal (HB No. 249), crossing Patti-Amritsar road and Kasur branch canal and again moving along the northern revenue boundary of village Dyal (HB No. 249), then moving towards south along eastern revenue boundary of village Dyal (HB No. 249), village Sahabpur (HB No. 250), village Chambal (HB No. 265) upto point 'C' which is the intersection point of revenue boundaries of village Chambal (HB No. 265), village Sheron (HB No. 266) of Local Planning Area, Tarn Taran and village Naushehra Pannuan (HB No. 269) of Local Planning Area, Patti.

SOUTH:-

Thence from point 'C' moving towards west along the southern revenue boundaries of village Chambal (HB No. 265), village Jatta (HB No. 264), village Sarhali Khurd (HB No. 252), village Jandoke (HB No. 241), crossing the Patti-Amritsar road and Patti-Amritsar railway line and again moving along the southern revenue boundaries of village Jandoke (HB No. 241), village Jaura (HB No. 239), crossing Kasur Branch canal and again moving along the southern revenue boundaries of village Jaura (HB No. 239), village Gopala (HB No. 237), village Mamanke (HB No. 236), eastern revenue boundary of village Dyal Rajputan (HB No. 232), then moving towards west along southern revenue boundary of village Dyal Rajputan (HB No. 232), then moving towards north along western revenue boundary of village Dyal Rajputan (HB No. 232), village Begepur (HB No. 233), village Gulalipur (HB No. 228), then moving towards south along southern revenue boundaries of village Sugga (HB No. 143), village Benka (HB No. 142), village Balair (HB. No. 141), eastern revenue boundary of village Sandhra (HB No. 135), crossing the Khalra-Hariker road and again moving along the eastern revenue boundaries of village Sandhra (HB No. 135), northern revenue boundary of village Makhi Kalan (HB No. 131), village Margindpura (HB No. 129), crossing Kasur branch canal and moving towards south along the eastern revenue boundaries of village Margindpura (HB No. 129), then moving towards west along southern revenue boundaries of village Margindpura (HB No. 129), village Theh Naushera (HB No. 130), village Kalsian Kalan (HB No. 121), village Algon (HB No. 95), then moving towards north along western revenue boundary of village Algon (HB No. 95), crossing Khemkaran-Amritsar road and continue moving along the western revenue boundary of village Algon (HB No. 95), crossing Kasur Branch Canal and again moving along the

outer western revenue boundaries of village Algon (HB No. 95), village Bhaini Massa Singh (HB No. 98), village Basarke (HB No. 69), southern and western revenue boundary of village Hundal (HB No. 70), village Basarke (HB No. 69), western revenue boundary of village Mari Kamboke (HB No. 68), southern revenue boundary of village Dal (HB No. 66) upto point 'D' which is intersection point of revenue boundaries of village Dal (HB No. 66), village Wan (HB No. 65) of Local Planning Area, Khemkaran and Indo-Pak international boundary.

WEST:- Thence from point 'D' moving towards north along Indo-Pak international boundary and western revenue boundaries of village Dal (HB No. 66), crossing UBDC canal and again moving towards north along western revenue boundary of village Dal (HB No. 66), village Kalsian Khurd (HB No. 104), village Khalra (HB No. 105), northern revenue boundaries of village Theh Kalla (HB No. 106), village Gilpan (HB No. 107), village Narli (HB No. 108), western revenue boundaries of village Chhina Bidhi Chand (HB No. 189), village Dhala (HB No. 181) and southern revenue boundary of village Naushehra (HB No. 177) upto point 'A' which is the starting point.

The boundaries of Local Planning Area Bhikhiwind town are specifically shown on the drawing No. DTP (ASR) 08/2019 dated 22-07-2019 revised on 03-12-2019.

All the provisions laid down under sub section (2) of section 56 of "The Punjab Regional and Town Planning and Development Act, 1995," and all the concerned rules framed under this Act have been taken into consideration.

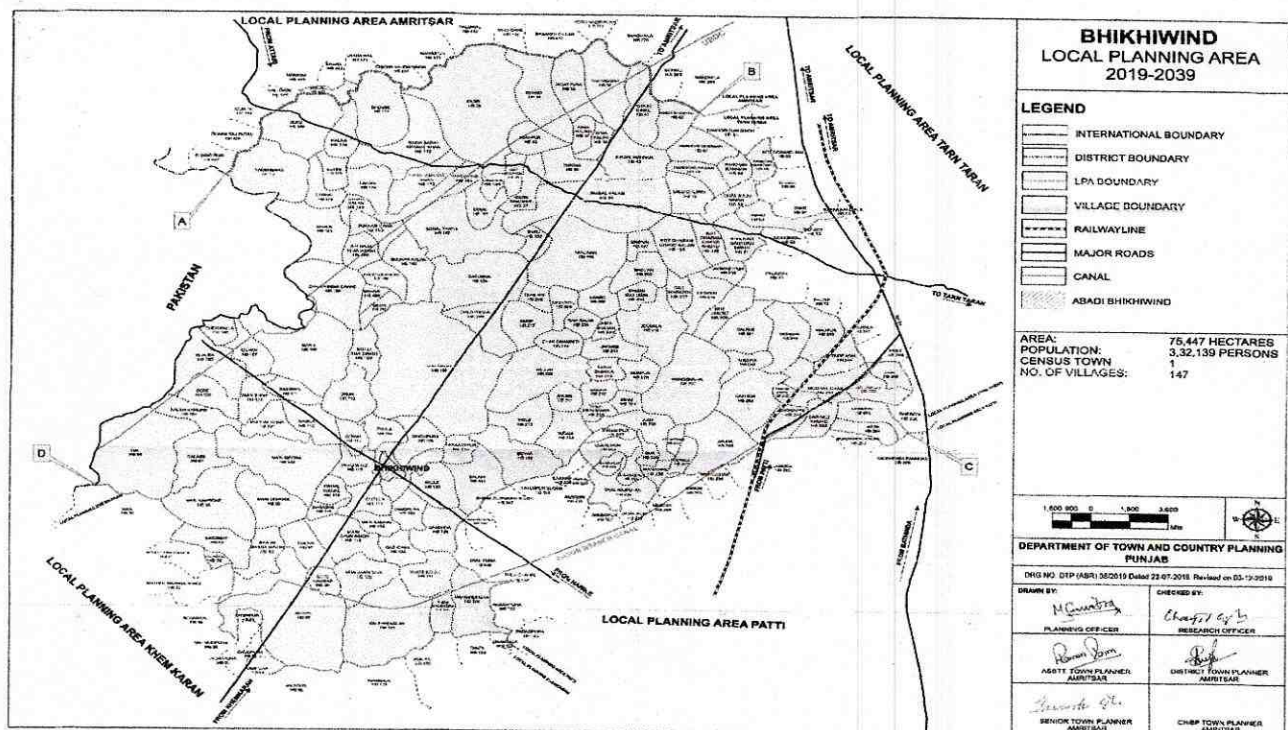
