No. 12/12/2020-4HG1/ 1264/A Whereas it appears to the Governor of Punjab that to meet the challenge of rapid growth of village Saroa of District SBS Nagar and to provide a workable frame work for comprehensive planned and regulated development, the preparation of statutory Master Plan of village Saroa is very essential. Hence in order to develop village Saroa of District Shaheed Bhagat Singh Nagar and its surroundings in an orderly manner and to prepare its Master Plan under "The Punjab Regional and Town Planning and Development Act, 1995" the Governor of Punjab pleased to declare the Local Planning Area of village Saroa within the meaning of sub section (1) of section 56 of "The Punjab Regional and Town Planning and Development Act- 1995". The total area of proposed Local Planning Area, village Saroa is **16768.00** hectares (41434.63 Acres) and Population is 62736 per Census persons as 2011 which including village Saroa and its adjoining 54 villages. The Schedule of Boundary of Local Planning Area is given below: -

SCHEDULE OF BOUNDARY

- NORTH:** Starting from point 'A' which is the intersection point of revenue boundaries of village Chandpur Rurki (H.B.No. 366) of district Shaheed Bhagat Singh Nagar and village Maira (H.B. No.481) of district Hoshiarpur, then moving towards east along the northern boundaries of village Chandpur Rurki (H.B.No. 366), village Chhuchhewal (H.B.No. 368), village Torowal (H.B.No. 369), village Pojewal (H.B.No. 371), village Singhpur (H.B.No. 373), crossing Garhshankar-Shri Anandpur Sahib road then again moving towards east along the northern boundary of village Singhpur (H.B.No. 373), then again moving towards north along the western boundary of village Malewal (H.B.No. 375), upto point 'B' which is the common meeting point of revenue boundary of village Malewal (H.B.No.375), village Sekhowal (H.B.No. 371) of District Hoshiarpur and village Gochar (H.B.No. 484) of District Roopnagar.
- EAST:** Thence from point 'B' moving towards south along district boundary of Roopnagar and eastern boundaries of village Malewal (H.B.No. 375), village Chandiani Kalan (H.B.No. 376), village Mangupur (H.B.No. 377), village Kukar Suha (H.B.No. 378), village Majhot (H.B.No. 379), village Shahbazpur (H.B.No. 380), upto point 'C' which is the common meeting point of revenue boundary of village Shahbazpur (H.B.No. 380), village Ghahi Majra (H.B.No.497) of District Roopnagar and village Nanowal (H.B.No. 232) of District SBS Nagar.
- SOUTH:** Thence from point 'C' and moving towards south along the southern boundaries of village Shahbazpur (H.B.No. 380), village Jhangerian (H.B.No. 226), village Bhanun (H.B.No. 227), village Kharaur (H.B.No. 173), village Chankoi (H.B.No. 174), village Gulpur (H.B.No. 175), crossing Balachaur-Hoshiarpur road (SH-24), then again moving towards west along the southern boundaries of village Gulpur (H.B.No. 175), village Karawar

(H.B.No. 176), village Rurki Mughlan (H.B.No. 177), village Barwa (H.B.No. 142), village Bhano Mazara (H.B.No. 140), village Bhagoran (H.B.No. 139), crossing Jalandhar Branch distributary then again moving towards west along the southern-western boundary of village Bhagoran (H.B.No. 139), upto point 'D' which is the common meeting point of revenue boundary of village Bhagoran (H.B.No. 139), village Sona (H.B.No. 134) of District SBS Nagar and village Simbli (H.B.No. 159) of District Hoshiarpur.

WEST: Thence from point 'D' moving towards east along the northern boundary of village Bhagoran (H.B.No. 139), crossing Jalandhar Branch distributary then again moving towards east along the northern boundaries of village Bhagoran (H.B.No. 139), village Barwa (H.B.No. 142), village Jainpur (H.B.No. 165) then moving towards north along the western boundaries of village Jainpur (H.B.No. 165), village Bakapur (H.B.No. 164), crossing Hoshiarpur-Balachaur road (SH-24) road, then again moving towards north along the western boundaries of village Bakapur (H.B.No. 164) , village Alowal (H.B.No. 242), village Saroa (H.B.No. 243), village Sahungra (H.B.No. 249), then moving towards east along the northern boundaries of village Sahungra (H.B.No. 249), village Saroa (H.B.No. 243), village Kulpur (H.B.No. 247), then moving towards north along the western boundaries of village Karimpur Dhiani (H.B.No. 246), village Karimpur Chahwala (H.B.No. 370), crossing Garhshankar – Shri Anandpur Sahib road, then again moving towards north along the western boundaries of village Karimpur Chahwala (H.B.No. 370), village Torowal (H.B.No. 369), village Bholewal (H.B.No. 367) then moving towards south along the southern boundary of village Chandpur Rurki (H.B.No. 366), then moving towards north along the western boundary of village Chandpur Rurki (H.B.No. 366), up to point 'A' which is the starting point.

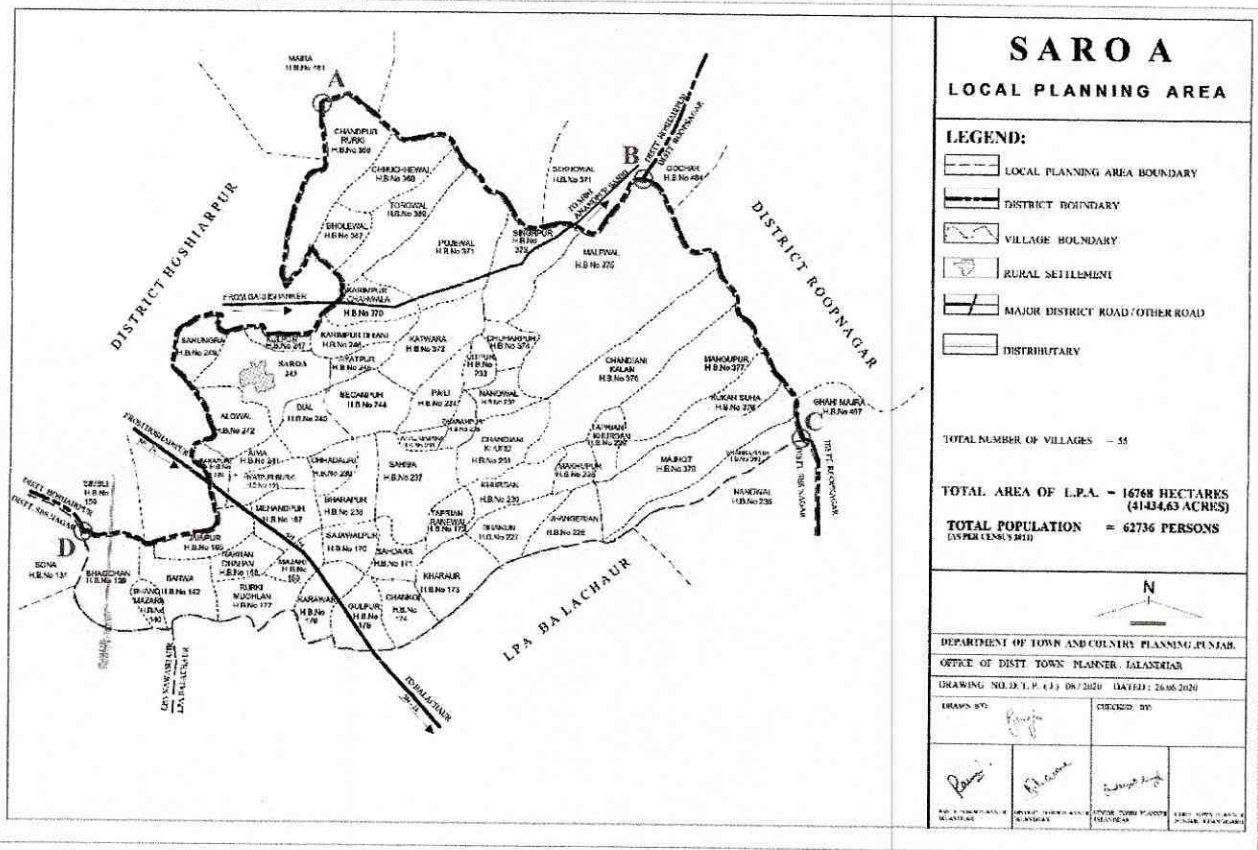
