Dear Sir/Madam,

As you are kindly aware, our Constitutional division of work places Foreign Policy in the Union List. However, in the current globalized context, it is increasingly in the interest of of the States/Union Territories to engage with the world so as to attract FDI, technology tie-ups, joint ventures, trade and tourism etc. Conscious of this need to facilitate and coordinate efforts of the governments of the various States/Union Territories, a full-fledged "States Division" has been created in this Ministry at the specific instruction of Hon'ble Prime Minister Shri Narendra Modi.

- 2. While States are keen to get what they need from the world, officials of governments of the States/Union Territories may not readily possess the requisite knowledge and professional skills. Thus, there is a felt need to provide necessary orientation and skills to those, who are entrusted with this task. In this context, this Division has been mandated to help capacity building of the officers from States/Union Territories in various aspects of international structures/protocol etc.
- 3. Against this background, it is proposed to conduct a training module for the benefit of senior officers from State/UT governments, as per the following outline:
- It would be for a duration of one working week, tentatively proposed from Monday, 4 January to 8 January, 2021 (excluding travel time).
- It would be in physical on-campus format at the Sushma Swaraj insitute of Foreign Service (SSIFS), New Delhi.
- It would tentatively have about 20 sessions: inter alia:
  - giving the big picture on international relations, including economic aspects;
  - focus on practical aspects of economic/commercial engagement covering trade, investment, connectivity, technology, tourism and also on studying the Global Best Practices on economic engagement.
  - Touch upon Protocol, Diaspora, Cultural and Consular work

- It would include suitable interactions with trade/ economic bodies/ICCR and economic Ministries in Government of India.
- The cost of the training programme can be borne by this Ministry/SSIFS, including for Lunch/Tea.
- The States/Union Territories governments are requested to pay for the round-trip passage to New Delhi, accommodation (in State Bhawans) and their local transport in Delhi. In case of any difficulty, it can be explored as to how to bridge any funding gap.
- 4. May I request you to kindly nominate one/two officers (second name can be stand by) to avail training programme. The officer (s) may be:
- (a) civil servants with about a decade of experience in public service;
- (b) those who have at least 5 years of residual service before superannuation;
- (c) who are currently/likely to be deployed in global interface work; and
- (d) who are proficient in English language.

A separate module for Secretaries/Principal Secretaries is -to be conducted later.

5. I shall be grateful also for your valuable suggestions/views on the course content, so as to make it practically relevant and useful. Your response by 4 December,2020 will be much appreciated, so that the training institution can suitably arrange for the programme.
