(Detailed Notice)

Notice inviting Applications for the post of Chairperson of State Police Complaints Authorities

Applications are invited for filling up of one post of Chairperson in the State Police Complaints Authority from eligible candidates, who are or retired Civil Services Officers not below the rank of Chief Secretary of the State Government or a Secretary to the Government of India or a retired Director General of Police of the State Government.

1. **Eligibility of Chairperson:-** A person shall be eligible to be appointed as Chairperson of the State Police Complaints Authority if he-

(a) is a citizen of India;

(b) is not holding an office of profit under the Central or State Government;

(c) does not hold any elected office, including that of a Member of Parliament or of a Member of State Legislature or of any local body under the Government;

(d) is not a member of or is associated in any manner with, an organization declared unlawful under any law;

(e) has not been convicted for any criminal offence involving moral turpitude; or for any other criminal offence;

(f) is not facing prosecution for any offence mentioned in clause (e) and against whom charges have not been framed by a court of law; and

(g) is not of an unsound mind.

2. **Term of office of the Chairperson:-** A person appointed as Chairperson shall hold office for a term of three years from the date on which he enters upon his office or till he attains the age of seventy years whichever is earlier.

3. **Resignation and removal of Chairperson:-** (1) The Chairperson of the State Police Complaints Authority may, by notice in writing under his hand addressed to the State Government, resign from his office.

(2) The State Government may remove the Chairperson on the following grounds, if he-

(i) is adjudged an insolvent; or

(ii) has been convicted by a criminal court at any time for an offence which, in the opinion of the State Government, involves moral turpitude; or

(iii) is persistently negligent to perform his duties; or

(iv) has acquired such financial or other interest which is likely to affect prejudicially his functions as a Chairperson; or

(v) is in a situation that would make him ineligible for appointment as per the conditions of eligibility mentioned in para 1 above.

State Government may also remove the Chairperson of the State Police Complaints Authority for any other reasons to be recorded in writing.

4. **Remuneration, allowances and terms and conditions of service of Chairperson:-** The remuneration and allowances payable to, and other terms and conditions of service of, the Chairperson of the State Police Complaints Authority shall be such as may be prescribed.

The applicants fulfilling eligibility criteria may forward their applications alongwith complete bio-data to the office of the undersigned, Room No. 219-220, 2nd Floor, Punjab Civil Secretariat-2, Sector-9, Chandigarh by 18.06.2021 upto 5.00 PM. Applications received after scheduled deadline shall not be entertained.
