- 1.0 Whereas the institutional and implementation arrangements envisaged as per operational guidelines of the Jal Jeevan Mission(JJM) Programme includes the establishment of a State Water and Sanitation Mission (Apex Committee & Executive Committee), State Level Scheme Sanctioning Committee (SLSSC), District Water & Sanitation Mission (DWSM) and Gram Panchayat Water & Sanitation Committee (GPWSC) to provide oversight to the programme design and implementation.
- 2.0 The existing Apex Committee of SWSM which was notified by Govt. vide letter no. 13/168/15-3B&R2/519481 dated 26.12.2015 under the chairpersonship of Hon'ble Chief Minister, Punjab is still in operation. In the 2nd meeting of SWSM held on 18.12.2020, approval was given to constitute a Steering Committee of SWSM under the Chairpersonship of Chief Secretary, Punjab which will be responsible for steering & monitoring the implementation of Jal Jeevan Mission Programme in the State. The present SWSM will function as an advisory Apex body of SWSM & the Steering Committee of SWSM will be responsible for framing policy guidelines, monitoring and implementation of JJM and other Water and Sanitation related programmes in rural areas of the State.
- 3.0 Therefore, the Governor of Punjab is pleased to constitute the Steering Committee of SWSM and to re-constitute the Executive Committee of SWSM, State Level Scheme Sanctioning Committee (SLSSC), District Water and Sanitation Mission (DWSM), in partial modification of earlier registration of SWSM vide No. 121 of 2009-10 by Registrar Firms and Societies Punjab Chandigarh for the implementation of Jal Jeevan Mission Programme as well as other water and sanitation programmes in the State, as follows:-

4.0 Steering Committee of SWSM

- 4.1 This committee will be responsible on behalf of Apex Committee of SWSM for providing policy guidelines and for overall monitoring, successful implementation of the JJM and other Water and Sanitation Programmes in the State.
- 4.2 The composition of Steering Committee of SWSM would be as under:-

5.0. Executive Committee of SWSM

- 5.1. Steering Committee of SWSM will be assisted by an Executive Committee under the Chairpersonship of Administrative Secretary in-charge of Department of Water Supply & Sanitation, with members from other departments / organizations. This committee shall perform functions as per operational guidelines of JJM/SBM (G) or any other programmes in vogue from time to time.
- 5.2. The composition of Executive committee of SWSM would be as under:-

6.0 State Level Scheme Sanctioning Committee (SLSSC)

6.1 As per operational guidelines under JJM, all the powers for planning, approval, implementation and monitoring of various projects under this programme have been assigned to the State. These powers shall be exercised by the State Level Scheme Sanctioning Committee under the chairpersonship of Administrative Secretary in-charge, Department of Water Supply & Sanitation.

6.2 The composition of SLSSC would be as under:-

7.0 District Water and Sanitation Mission (DWSM)

- 7.1 At the district level, DWSM will be responsible for overall implementation of Jal Jeevan Mission & Swachh Bharat Mission (Gramin) and other water & sanitation programmes in district under the chairpersonship of Deputy Commissioner / District Collector (DC).
- 7.2 The composition of DWSM would be as under:-

Note – DWSM may co-opt eminent persons from the field of water management, sanitation, community health, community development, etc. and local MP as members/any other officials as member special invitee.

8.0 Gram Panchayat Water & Sanitation Committees (GPWSC)

- 8.1. As per operational guidelines under JJM, the community will play a lead role in planning, implementation, management, operation and maintenance of in-village water supply infrastructure thereby resulting in FHTCs in every rural household. The willingness of community, reflected through Gram Sabha resolution and community contribution, will be the foremost criterion for planning of water supply system in villages.
- 8.2 Department of Water Supply & Sanitation, (B&R-II Branch) Govt. of Punjab has already notified constitution of GPWSC vide letter no. 13/1976/2015-3B&R2/519781/1-10 dated 26.06.2015 & letter no.13/1976/2015-3B&R2/519699/2 dated 26.06.2015 in which detailed guidelines regarding constitution, composition, tenure, powers & responsibilities etc including roles and responsibilities of GPWSCs for planning, implementation and O&M of water supply schemes have already been notified, which are as per the operational guidelines of JJM. Accordingly, the same guidelines shall be applicable under JJM except that the notifications mentioned above stand amended to the extent that 50% of the total members of the GPWSC's shall be women.
- **9.0** Above committees will be responsible for planning and monitoring of all the Centrally Sponsored water and sanitation sector programmes such as JJM, SBM-G & other state sponsored programmes such as World Bank funded PRWSSIP, NABARD aided projects, augmentation and rehabilitation of existing infrastructure under major head 4215 etc. which are being executed at the State, District and village level by dovetailing funds available under these programmes.
- **10.0** Non-official members of the Mission would be entitled to TA/DA as allowed by the Punjab Government to its Group-A officers. The officials members of the committee shall draw their TA/DA from their respective departments/agencies.
- **11.0** The Steering Committee of SWSM may meet as often as required but it shall meet at least once in a quarter.
- **12.0** This notification is in continuation and partial modification of earlier notifications in this regard.
