In exercise of the powers conferred under Sub Section (1) of Section 162 of the Electricity Act, 2003 read with Sub Regulation (2) of Regulation 30 and Regulation 43 of Central Electricity Authority (Measures relating to Safety and Electrical Supply), Regulation, 2010 as amended upto date, the State Government, hereby, notifies

- i) 66 KV as the notified voltage for the purpose of periodical inspection and testing the installation belonging to the supplier or consumer by way of self-certification in compliance to Sub Regulation (2) of Regulation 30 of Central Electricity Authority (Measures relating to Safety and Electrical Supply), Regulation, 2010 and its upto date amendments and;
- ii) 650 volts as the notified voltage for the purpose of inspection, testing by the owner of the installation before commencement of supply or re-commencement after shut-down for six months and above by way of self-certification in compliance to Regulation 43 of Central Electricity Authority (Measures relating to Safety and Electrical Supply), Regulation, 2010 and its upto date amendments.

The owner of the installation(s) of voltage equal to and below the notified voltage is authorized to issue self-certification as per procedure to be laid down separately in respect of installations under Regulation 30 and 43 with the assistance of Chartered Electrical Safety Engineer authorized under Regulation 5 A of the regulations ibid.


