RULES

- 1. (1) These rules may be called the Punjab Prosecution and Litigation (Group 'A') Service (First Amendment) Rules, 2021.
- (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- 2. In the Punjab Prosecution and Litigation (Group 'A') Service Rules, 2002 (hereinafter referred to as the said rules), in rule 6, for sub-rule (2), the following shall be substituted, namely:-
 - "(2) The authority empowered to impose penalties as specified in rule 5 of the Punjab Civil Services (Punishment and Appeal) Rules 1970 shall be the Secretary Incharge and the Appellate Authority there under in respect of the members of service shall be the Minister Incharge."
- 3. In the said rules, for Appendix 'A', the following Appendix shall be substituted, namely:-
