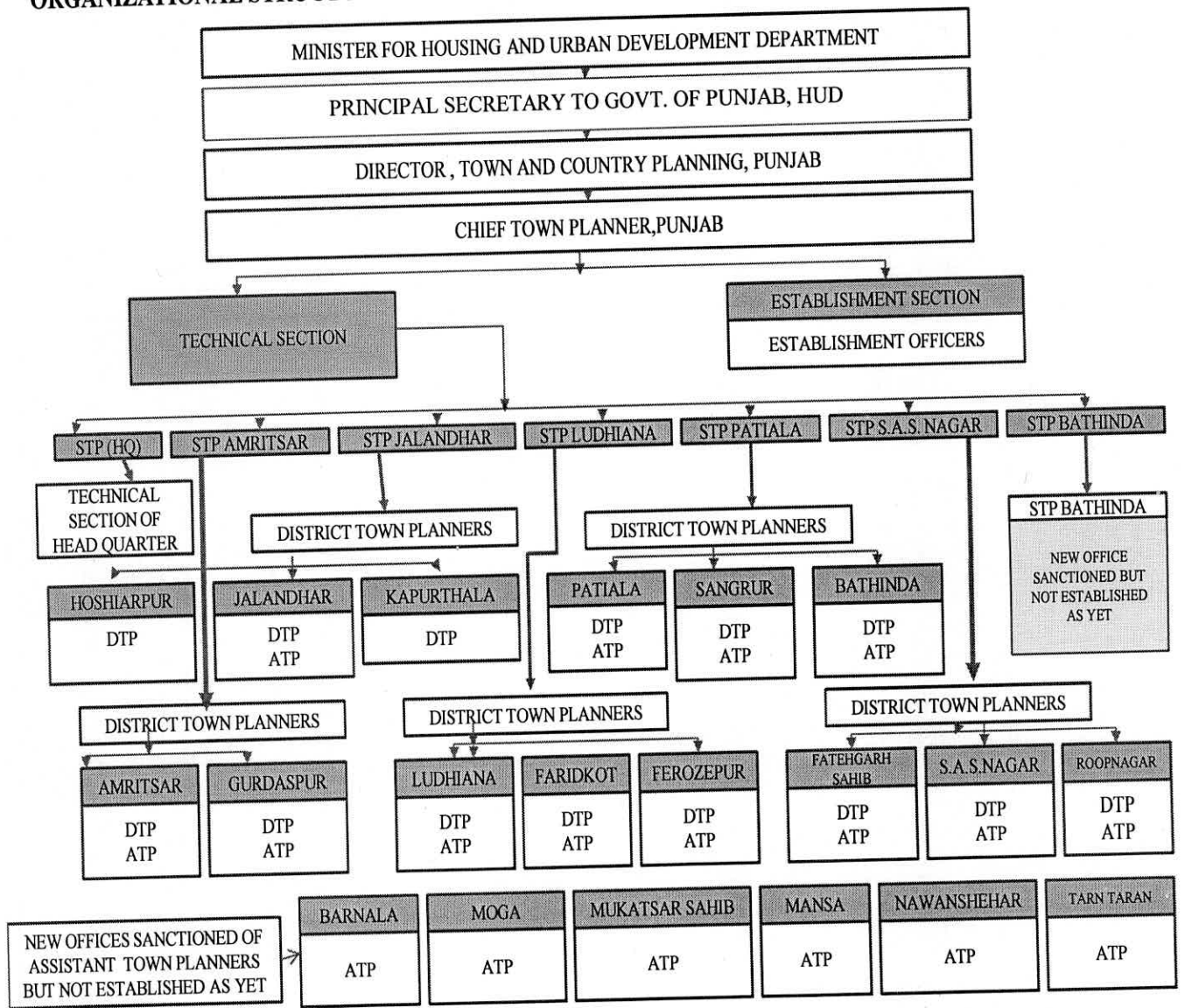

Functions of Department of Town and Country Planning, Punjab.

- i) Formulation of Regional & Urban Development Strategy.
- ii) Preparation of Regional Plans & Master Plans , under the Punjab Regional & Town Planning and Development Act 1995.(Amended) 2006, for the town and cities for their orderly growth and development.
- iii) Surveying & mapping of Regional Planning Areas and Local Planning Areas of cities & towns including aerial photography by remote sensing techniques.
- iv) With a view to include private sector for active participation in the urban development, State Govt. has approved number of Mega Housing Projects.
- v) To simplify and expedite the approval of Change of Land Use, Town and Country Planning Department has been designated as the nodal agency.
- vi) In order to encourage and provide social and economic infrastructure the state government has formulated the policy regarding establishment of Hospitals, Hotel, Industries, and sports activities, and the department provides assistance for clearance of such projects.
- vii) The department also provides assistance for the clearance of sites of industrial units with regard to Master Plan proposals for creating healthy environment.
- viii) Scrutiny of colony layout plans under the Punjab Apartment & Property Regulations Act & Rules 1995 for promoting planned growth & development in the private sector.
- ix) Providing technical assistance to the department of Industries, Punjab Small Scale Industries & Export Corporation, Punjab Pollution Control Board and the Department of Science, Technology and Environment regarding setting up of Industrial Focal Points, scrutiny of Projects from environmental angle of cases involving establishment of Industrial units.
- x) Selection of sites of projects of various Govt. departments/agencies and processing of related cases for consideration of the State Land Acquisition Board.
- xi) Planning of surplus Govt. lands and properties under OUVGL schemes.
- xii) Preparation of traffic operation schemes of urban areas.
- xiii) Providing technical support to the District Administration and Govt. on matters related to planning and execution of various schemes and projects.
- xiv) For setting up of Mobile Network Towers site clearance is being accorded to various Mobile companies.
- xv) Advice on building applications referred to by the Development Authorities, and the scrutiny of cases for siting of brick kilns, petrol pumps and cinema houses referred by the District Administration.
- xvi) Approval of Building Plans of standalone projects outside Municipal committee/Municipal Corporation limits.

Delegation of powers and duties of its officers & employees of Town and Country Planning Department.

Chief Town Planner

- To tender technical advice to all the field offices, and State Government
- Coordinates with government for all type of development works.
- Scrutiny of the cases received from the field offices.
- Where Master Plans are notified, Scrutiny of Change of Land Use cases received from STP office beyond their stipulated areas, after scrutiny cases are referred to Hon'able Minister (HUD) for approval.
- Where Local Planning Areas are notified but Master Plans are yet to be prepared, Scrutiny of Change of Land Use cases is done at CTP office and referred to Hon'able Minister (HUD) for approval.
- Scrutiny of Layout plans of all kinds (as per their stipulated areas as notified by the government from time to time) and shall be approved technically.
- Members of different technical committee's (for technical advice) constituted by the government. Tender advice and Policy making for all type of development works in the state.
- Scrutiny of Master Plans and Regional Plans prepared by the field office, and refers to the government for approvals and other processes.
- Amendments in the Master Plans as required from time to times in consultation with the Punjab Regional and Town Planning and Development Board.
- Dealing with the court cases at State level.
- Reporting of Mega Projects to Nodal Agency.
- Reporting of Competent State Authority cases to the committee.
- Approval of new mandi's and approval of reserved pockets of existing mandi's.
- Selection of sites of projects of various Govt. departments/agencies and processing of related cases for consideration of the State Land Acquisition Board.

Providing technical assistance to the department of Industries, Punjab Small Scale Industries & Export Corporation, Punjab Pollution Control Board and The Department of Science, Technology and Environment, regarding setting up of Industrial Focal Points, Scrutiny of Projects from environmental angle of cases involving establishment of Industrial units.

Senior Town Planners

- Coordinating and supervising the technical works of field offices.
- Coordination between Field office and CTP office for technical works.
- Tender technical advice to all the DTP's under their jurisdiction.
- Scrutiny of all the cases received from the field offices.
- Scrutiny of Master Plans and Regional Plans prepared by the field offices and refer to CTP for further process.
- Where Master Plans are Notified, Cases of Change of Land Use and layout plans are approved by STP up to the stipulated areas notified by Government from time to time.
- Field reports are scrutinized at STP office regarding CLU cases beyond their stipulation. They are further referred to CTP office for approval.

District Town Planners

- Coordinates and supervises the work of ATPs and other technical staff working under them.
- Preparation of local planning area maps.
- Preparation of existing land use plans.
- Preparation of Proposed Land Use plans.
- Surveys and data collection for the master plans.
- Preparation of Master Plans and Regional Plans of Local Planning Areas falling under its jurisdiction.
- Preparation of layout plans of government projects like OUVGL site etc.
- Tender advice on siting of petrol pumps, Cinema houses, cold storages etc. under the relevant act and rules, on reference from Deputy Commissioners/ Executive Engineers.
- Issuance of NOC's regarding Rice shellers, Brick kilns and petrol pumps.
- Field reports for all the cases of CLU, CSA cases and Mega Project cases referred to the concerned STP for further Process.
- Convener the Think Tank meeting at district level for Master Plan Preparation.
- Dealing of Court cases of the areas under their jurisdiction.






